This scholarship is a three-year scholarship of \$1,460 per year of attendance for students attending GSBC for the first time. Those applying for second year direct admission are not eligible.

GSBC ADMISSION REQUIREMENTS

Admission requirements are designed to select an individual who, based on experience and prior education, will derive the greatest benefit from this advanced bank management program.

Qualifying criteria:

- Applicant must be employed by a taxable, FDIC-insured financial institution*, its holding company, regulatory agency or closely related affiliate. Applicant must get approval from a direct supervisor.
- Applicant's bank/institution must be a member of the OBA.
- Applicant must possess a minimum of three years of experience in the banking industry or closely related field.
- Applicant must hold a bachelor's degree or compensating experience.

*Preference will be given to individuals who work for a community bank.
