It is with great honor that I nominate Carlisle Mabrey III for the 2020 Oklahoma Bankers Hall of Fame. Over the last 48 years, Carlisle has had a distinguished career in banking in Oklahoma, while also serving in countless leadership roles across the state. Throughout each role, he has led with a steadfast commitment to improving the lives of Oklahomans, delivering high quality products and service to help local businesses grow, and enhancing the banking industry as a whole.

After serving as a Captain in the US Air Force JAG Corps, Carlisle joined his father at Citizen's National Bank in 1972. At that time, it was a successful community bank operating in Okmulgee with approximately \$13.5 million in assets. Over 4 decades as CEO, the bank, known now as Mabrey Bank, grew significantly to \$1.2 billion in assets, 15 full-service locations across the state and more than 230 employees.

Carlisle has also dedicated his time and resources to advocate for the business community, our citizens, and our economy through many roles, such as Mayor of Okmulgee, a Commissioner for the Oklahoma Department of Transportation, Chairman of the GRDA, Chairman of the Okmulgee Chamber of Commerce and Chairman of the Okmulgee Hospitality Authority. Currently, he serves on the Board of Directors of Trust Company of Oklahoma, the Board of Advisors of the Tulsa Regional Chamber of Commerce, and on the Board of Trustees of both Philbrook Museum and the University of Oklahoma Foundation.

In the banking industry specifically, Carlisle has demonstrated his commitment to the development, improvement, and growth of the industry as a member of the Board of Directors of the OBA, serving as Chairman in 1998, the State Banking Board, and through his service on the Board of Directors of the Oklahoma City Branch of the Federal Reserve and the ICBA.

While every role throughout Carlisle's career has been meaningful, what I most admire about him is his unwavering commitment to leading with integrity and honor. He has been an invaluable asset to the state and the banking industry while serving as a role model for so many.
