Chris Turner was President and CFO of The First State Bank in Oklahoma City which was recently acquired by First National Bank & Trust where he currently serves as its Chief Operations Officer. A 40+-year veteran banker in Oklahoma City, Mr. Turner was associated with Local Oklahoma Bank for 26 years, prior to its acquisition by IBC Bank in 2004. He served in various capacities including Internal Audit Director, Marketing Director, Director of Mergers and Acquisitions and ultimately Executive Vice President for Branch Administration and Retail Sales. He was the architect of the bank's Retail Sales Culture, which resulted in phenomenal growth in retail accounts and fee income.

Turner currently serves as the Chairman of the INTEGRIS Health Board of Directors where he provides oversight as a member of the Governance, Safety & Quality, Finance, Investment, Audit/Compliance and Strategy Committees. He is also a past chairman of the INTEGRIS Baptist Medical Center board.

After retiring from IBC Bank in 2007, he and two partners acquired The First State Bank, Oklahoma's Oldest Bank (chartered in 1902). The acquisition was completed in April 2009, and since that time the bank grew from \$20 Million in assets to over \$400 Million. He facilitated its sale to First National Bank & Trust of Shawnee, in July 2021 resulting in the largest Native American owned bank in the country. First National is owned by the Citizen Potawatomi Nation tribe.

In addition to Integris Health, he also serves on the Board of Directors for the OKC Branch of the Federal Reserve of KC. He has served on the boards of The Alliance for Economic Development for OKC, Oklahoma State Fair, Progress OKC and United Way of Central Oklahoma. He is a lifetime member and has served on the board of The Urban League of Greater Oklahoma City. He was inducted into the Oklahoma City Public Schools Foundations Wall of Fame and has served on numerous other non-profit organization boards over his career.

In 2020 he led a private/ public partnership group to help fund the first new full service grocery store in Northeast OKC in over 40 years (recognized as a food desert and predominantly minority community). This \$11 million construction project was done in cooperation with Homeland Grocery Stores, City of Oklahoma City, The Alliance for Economic Development and other participants. In 2020 Chris was also recognized by the Journal Record, receiving the Oklahoma's Most Admired CEO's and Financial Steward Award.

A native of Oklahoma City and graduate of Northeast High school, he attended college at Morehouse in Atlanta and completed studies at Central State University (UCO), majoring in Accounting. He is a member of Trinity Presbyterian Church in Northeast OKC where he serves as an Elder.

He has been married for 42 years and has two sons who also reside in OKC.
