Robert became President and CEO in 1995, and under his direction 6 additional branches were established. Robert takes a very active role in many civic organizations including the Midwest City Chamber of Commerce, Wickline United Methodist Church, Rose State College Scholarship Foundation, and has been a member of the Midwest City Rotary Club since 1963. He was appointed by the Governor of Oklahoma in 1993 as a Regent of Rose State College and served two terms as Chairman of the Regents. Robert and his wife Linda have been married for 59 years raising 3 children, William, John, and Shelly in Midwest City. They are very proud to have six grandchildren and eight great-grandchildren.
